

Fire Rated Construction in the IBC Seminar
Thursday, June 23, 2011

This is a continuing education course for building officials, code enforcement officers, inspectors and other professionals involved in inspecting, reviewing, designing and constructing occupied structures.

The subject matter is based on the 2006 Edition of the IBC and includes selected changes from the 2009 IBC. The course is a study of code requirements for specific details for rated construction wherever required in the building and related codes. It offers study about rated construction requirements, code options to rated construction, protected opening requirements and sources for specifying details for rated construction.

The seminar provides 6 hours of continuing education credit **approved** by the SC Building Codes Council and 6 hrs by AIA. The cost is \$150 per person. The moderator is Robert L. Harkins, ICC Certified Master Code Professional and CBO.

1. Learn the types of fire rated construction referenced in the International Building Code
2. Learn the details for fire rated construction assemblies referenced in the International Building Code
3. Learn where the different types of fire rated construction are required and the required time rating
4. Learn sources for fire rated assemblies and how to calculate rated assemblies
